- 1. Elect Secretary: Dixie Keyes
- 2. Fall 2017 Enrollment update reviewed
  - a. Comments from Rebecca:
    - i. ACT average went up slightly
    - ii. Average high school GPA also went up a bit
    - iii. Yet...smaller number of freshmen
    - iv. Strong retention in honors college (from 97-98%)
  - b. Fall recruitment underway
    - i. We don't use "super scores."
    - ii. A-State scholar website is being tested
    - iii. We previewed the listing of Institutional Scholarships for 2018-19
    - iv. Emphasize applications be in by December 1, 2017!! Will help students get all possible scholarships.
    - v. Many of the scholarships (excellence, leadership, pride) are automatic given appropriate ACT score.
    - vi. A-State Scholar requires more (30 each year)—writing, letters of recommendation. Is competitive. Honors College organizes this entire process (recruiters, financial aid, and others). Those on the waitlist may get it if others choose not to attend A-State.
    - vii. Senior Preview Day on Oct 28<sup>th</sup> has been cancelled (it's a ACT day)
    - viii. New event: LR Recruitment Event Oct 17<sup>th</sup>
- 3. Spring 2018 Honors Course
  - a. HNRS Special Topics from Hendershot course to approve
    - i. "Psychoanalysis and Rock and Roll"
    - ii. We reviewed the course and Rebecca asked for questions.
    - iii. Moved to approve: Dr. Ford; Seconded: Pam Towery
    - iv. All in favor—unanimous approval
- 4. Honors Experience Grants (student fee money) & Brainy Break
  - a. Accessible on website; faculty recommendation
  - b. Most involve study abroad experiences
  - c. We heard about the DC trip Chad organized—"Brainy Break" during Spring Break
  - d. Application for Brainy Break will be opened next week
  - e. Rebecca provided some history of Brainy Break—the study abroad experiences showed that our students also need to explore America.
- 5. Honors Council Representative role
  - a. Honors Option—vetting opportunities in our program areas that is higher order thinking, appropriately "more" for honors students, opportunities to help them

- grow and expand. Call Rebecca if you review an option form that isn't quite up to par.

  - e. Jennifer will speak about these to any group; faculty is her biggest ally
  - f. Gilman, Fulbright, Rhodes, TFA, and NSF graduate fellowship coming up
  - g. Fellowship opportunities are not just for honors students
