

NSF Current and Pending Support

Last updated: May 10, 2024

For proposals submitted or due on or after May 20, 2024, an updated Current and Pending Support form must be used to comply with the NSF Proposal & Award Policies & Procedures Guidelines ([PAPPG 24-1](#)).

Current and Pending Support information must be created for each individual designated as Senior Personnel on a proposal using [SciENcv](#). Information can be entered into SciENcv to produce an NSF-compliant PDF and may be saved for use in future submissions. Proposers must save the PDF locally and submit it as part of their proposal submissions via Research.gov (preferred) or Grants.gov.

[Current and Pending Support](#) is used to assess the individual's capacity to carry out the proposed research and any potential scientific and budgetary overlap/duplication, as well as overcommitment with the proposed project.

Refer to the [NSF Pre-award and Post-award Disclosures Relating to the Biographical and Current and Pending Support](#) table for guidance about types of activities to be reported, where they should be reported, when updates are required during the proposal and award lifecycle, and a list of activities that are not required to be reported.

The following information must be provided on each Senior Person's Current and Pending Support form:

(1) Identifying Information

- Name, ORCID ID (optional; see <https://orcid.org/> for more information), Current Position Title

(2) Primary Organization and Location

- Name of individual's primary organization and its location (city, state/province, and country)

(3) Projects/Proposals (see [PAPPG Chapter II.D.2.h\(ii\)\(g\)\(iii\)](#))

Provide the following for the Senior Person's existing projects as well as projects under consideration for funding in accordance with the definitions of "Current" and "Pending" provided below:

- Project/Proposal Title
- Status of Support – select Current or Pending
 - Current: All ongoing projects whether such support is provided through the proposing organization or provided directly to the individual
 - Pending: Any proposal currently under consideration for funding (including this proposal) whether such support is provided through the proposing organization or directly to the individual. **In addition, any proposals likely to be submitted immediately or in the near future must be reported.**
 - Entries should be grouped together based on Status of Support (i.e., all Current entries should be listed first and all Pending entries to follow)
- Proposal/Award Number (if available)
- Source of Support (i.e., name of sponsor/entity providing support)
 - Include all federal, state, local, foreign, public, or private foundations, non-profit organizations, industrial or other commercial organizations or internal funds allocated towards specific projects
- Primary Place of Performance
 - Enter primary location (city, state/province, country) where project/activity will be conducted. Indicate “virtual” if project is not based in a physical location.
- Project/Proposal Start Date and End Date (MM/YYYY format)

- Total Award Amount (including Indirect Costs)
 - If support is in a foreign currency, convert to US dollars at time of submission
- Person Months (or Partial Person Months) Per Year Committed to the Project
 - Enter how much time the Senior Person anticipates is necessary to complete the project scope
 - Enter the number of person months (even if unsalaried) for the current budget period and each subsequent budget period
 - If budget period person months span two calendar years, enter the latter in the Year field.
 - If a time commitment is not readily ascertainable, reasonable estimates should be provided
- Overall Objectives
 - Field is limited to 1500 characters
- Statement of Potential Overlap
 - Describe the potential overlap between this proposal and any pending proposal or current award in terms of scope, budget, or person months planned or committed. If there is no overlap, enter N/A.

(4) In-Kind Contributions

In-kind contributions include, but are not limited to, office/laboratory space, equipment, supplies, and employee or student resources. Provide the following details for each contribution:

- Status of Support (Current or Pending – see definitions above)
- In-Kind Contribution Start Date and End Date (MM/YYYY format)
- Source of Support (i.e., name of sponsor/entity providing in-kind contribution)
- Summary of In-Kind Contribution(s)
- Person Months (or Partial Person Months) Per Year Associated with the In-Kind Contribution
- U.S. Dollar Value of In-Kind Contribution
 - If the dollar value is not readily ascertainable, reasonable estimates should be provided
 - If support is in a foreign currency, convert to US dollars at time of submission
- Overall Objectives
- Statement of Potential Overlap

(5) Certification

Current and Pending Support forms will require each Senior Person to certify that the information on their Current and Pending Support is current, accurate, and complete and reflects support from both foreign and domestic sources. They must also certify that they are not party to a [Malign Foreign Talent Recruitment Program](#).

To certify Current and Pending Support in SciENcv:

Once the document has been completed in SciENcv, the Senior Person will download it as a PDF and be prompted to agree with the following certification statement, which will be printed at the end of the PDF with their name and a date/time stamp:
